PLEASE PROVIDE A COPY TO YOUR PAYROLL DEPT.

Please find attached a letter from Brian Zdrilic identifying the distribution of the one dollar and fifty cents (\$1.50) increase scheduled for May 1, 2009. You will also find attached a copy of the Pension and Union Funds form.

Please note that the total one dollar and fifty cent (\$1.50) increase is being allocated by the Millwrights Local Union 2736 to the Pension Plan which will increase the present three dollars (\$3.00) per hour earned to four dollars and fifty cents (\$4.50) per hour earned.

Therefore, there is no wage increase effective May 1, 2009. The membership has chosen to not take a wage increase and instead provide more funding to their Pension Plan due to current pressures on Pension Plans because of the economy.


