Happy New Year from the CLR team. We hope the new year will be the one of success and overcoming adversities we faced in 2020. Here at CLR we will continue to proudly serve our members community through our services, programs, informational support and *Building Relationships*.

[COVID-19 Update](#)

According to the latest update from Dr. Bonnie Henry on Monday, another 2,211 people tested positive for COVID-19 in B.C. over the past four days, and 45 people died from the disease over the same period. Of the new cases, 565 tested positive between Thursday and Friday, 607 between Friday and Saturday, 500 between Saturday and Sunday and 539 over the past 24 hours. There are more than 6,823 active cases in B.C. currently. More than 8,700 people are under active health monitoring.

In their last update of Dec. 31st, Dr. Bonnie Henry and Health Minister Adrian Dix announced 683 new cases of COVID-19 and eight more deaths. Three new health-care outbreaks were announced Thursday, at Williams Lake Seniors Village, Ridge Meadows Hospital and the Langley Memorial Hospital long-term care centre.

B.C. recorded an average of 482 cases per day last week, which represented quite a drop from the average of 758 at the end of November. However the testing decreased over the holidays, which could account for the some of the recent drop. To check the COVID19 update follow <https://bc.ctvnews.ca/>.

[BC's plan for vaccine distribution](#)

BC Centre for Disease Control (BCCDC) is working closely with partners across B.C., including all regional health authorities and the First Nations Health Authority, to ensure the system is ready to receive, handle, store and distribute all vaccine types. With phased distribution of a vaccine, the first groups to get vaccinated between December and February will include: residents, staff and essential visitors to long-term care and assisted-living residences; individuals in hospital or community awaiting a long term care placement; health care workers providing care for COVID-19 patients in settings like Intensive Care Units, emergency departments, medical/surgical units and paramedics; remote and isolated First Nations communities. From February to March, the immunization program will expand to include more categories of population.

Canada has so far approved two vaccines: by Pfizer-BioNTech (Dec. 9) and Moderna (Dec. 23). Both vaccines require two doses a number of weeks apart for full efficacy. As of Sunday, Canada had administered 119,202 coronavirus vaccines across the country, according to [COVID-19 Tracker Canada](#). In B.C. the number of doses administered reached 17,510, which represents the ratio of 345.2 per 100,000 population. Visit [GlobalNews](#) to find out more.

The Government of Canada is taking immediate, significant and decisive action to support Canadians and businesses facing hardship as a result of the COVID-19 outbreak.

Under "Supporting skills training and employment" the federal government is investing an additional \$1.5 billion in the Workforce Development Agreements with provinces and territories to offer Canadians the skills training and employment supports they need. This support will respond to the increased number of Canadians looking to re-enter the workforce, and targets workers and employers in sectors hardest-hit by COVID-19. The Agreements also offer flexibility to provinces and territories to respond to the diverse employment and skills training needs of Canadians. This is in addition to the \$3.4 billion already being provided to provinces and territories under the Labour Market Development Agreements and Workforce Development Agreements in 2020-2021.

[B.C. health order restricts number of workers at large industrial work sites](#)

British Columbia's public health officer has ordered five major industrial projects in the north of the province to reduce the size of their workforces in an attempt to ensure the northern health region does not become overwhelmed with COVID-19 cases. Those sites include the Site C dam project near Fort St. John, the LNG Canada Project natural gas liquefaction and export facility in Kitimat, the Coastal GasLink natural gas pipeline being built from Dawson Creek to Kitimat, a tunnel being twinned near Kitimat for Rio Tinto's aluminum smelter, and the Trans Mountain Pipeline from Edmonton to Burnaby.

According to Henry, the order is needed to try to prevent the spread of the virus.
