### [Stay safe on the road during the B.C. Day long weekend](#)



As the B.C. Day long weekend approaches, travellers are encouraged to stay safe on the road by planning ahead, using extra caution and being prepared for higher-than-normal traffic volumes.

Drivers can expect delays on Coquihalla Highway 5 as portions of the highway are one lane in each direction, due to damage from the November 2021 atmospheric river and ongoing reconstruction work. The heaviest traffic volumes on the Coquihalla are

anticipated from noon until 8 p.m. daily.

### [B.C. encourages parents to register children under 5 for COVID-19 vaccine](#)



Approximately 208,000 eligible infants and children in British Columbia between six months and four years of age will soon be able to receive vaccine protection against COVID-19.

Following Health Canada's approval of the Moderna vaccine, and the National Advisory Committee on Immunization's (NACI) recommendation on its use, for those aged six months to four years, regional health authorities will start offering this vaccine at clinics throughout the province on Aug. 2, 2022.

### [Monkeypox: Outbreak update](#)

The Public Health Agency of Canada (PHAC) is working with provincial and territorial public health partners to investigate cases of monkeypox in Canada. As the investigation evolves, it is anticipated that additional cases will be reported in Canada. Provinces and territories have publicly reported 745 cases of monkeypox as of July 27, 2022 at 12:00 pm EDT.

PHAC is continuing to collect and analyze epidemiological information reported by the provinces and territories to help define the national scope of the investigation and to determine if there are any increased health risks to people in Canada.

### [WorkSafeBC reminds employers to keep both indoor and outdoor workers safe from heat stress](#)

Last year, B.C. was impacted by a record-setting heat dome with extreme temperatures throughout the province. As a result, WorkSafeBC accepted 115 claims from workers related to heat stress in 2021, a 180% increase over the average of 41 claims in the previous three years.

To prevent heat-stress injuries, WorkSafeBC requires employers to conduct heat stress assessments. As appropriate, employers must have a heat stress mitigation plan that provides education and training in recognizing the symptoms of heat-related injuries.

WorkSafeBC encourages employers to engage their workers early in the process so they understand the risks, and participate in the assessment and control of those risks.

### [Canada's Building Trades Unions \(CBTU\) selected as an intermediary for the Apprenticeship Service Program](#)

Canada's Building Trades Unions (CBTU) have been selected as an intermediary for the Apprenticeship Service Program – a federally-funded program that will help apprentices get started in the skilled trades. CBTU will connect first-year apprentices in eligible Red Seal Trades with job opportunities with small and medium-sized employers (SMEs) with the goal of hiring 4,000 first-year apprentices including 20 per cent participation from equity-deserving groups over the course of the next two years.

SMEs will receive \$5,000 for each first-year apprentice they hire in an eligible Red Seal Trade and \$10,000 if the apprentice is hired from an equity-deserving group. Additional employer supports will also be available.

The project has started, and will continue to March 2024 in four regions: Eastern Canada, Central Canada, the Prairies, and Western Canada. CBTU has partnered with SkillPlan and SRDC and will work with the CBTU National Advisory Committee to guide the project.

Superintendent with Aecon Mining, and Labrador and Industrial/Indigenous and External Relations Manager with Astaldi Canada.

### [Improved transit, connected communities on the way with Surrey Langley SkyTrain](#)



The first rapid transit project south of the Fraser River in 30 years reached a new milestone with the release of the business case and formal approval of provincial funding for the project.

The business case estimate for the capital cost of Surrey Langley SkyTrain is \$3.94 billion, including \$2.4 billion for the Province's share of the project, and a federal commitment of up to \$1.3 billion, with the remainder coming from local government.
